AGREEMENT TO TERMS

These Terms of Use constitute a legally binding agreement made between you, whether personally or on behalf of an entity (“you”) and KnoCard LLC (“**Company**”, “**we**”, “**us**”, or “**our**”), concerning your access to and use of the <http://www.knocard.com> website and mobile app as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the “Site”). You agree that by accessing the Site, you have read, understood, and agreed to be bound by all of these Terms of Use. IF YOU DO NOT AGREE WITH ALL OF THESE TERMS OF USE, THEN YOU ARE EXPRESSLY PROHIBITED FROM USING THE SITE AND YOU MUST DISCONTINUE USE IMMEDIATELY.

Supplemental terms and conditions or documents that may be posted on the Site from time to time are hereby expressly incorporated herein by reference. We reserve the right, in our sole discretion, to make changes or modifications to these Terms of Use at any time and for any reason. We will alert you about any changes by updating the “Last updated” date of these Terms of Use, and you waive any right to receive specific notice of each such change. It is your responsibility to periodically review these Terms of Use to stay informed of updates. You will be subject to, and will be deemed to have been made aware of and to have accepted, the changes in any revised Terms of Use by your continued use of the Site after the date such revised Terms of Use are posted.

The information provided on the Site is not intended for distribution to or use by any person or entity in any jurisdiction or country where such distribution or use would be contrary to law or regulation or which would subject us to any registration requirement within such jurisdiction or country. Accordingly, those persons who choose to access the Site from other locations do so on their own initiative and are solely responsible for compliance with local laws, if and to the extent local laws are applicable.

The Site is intended for users who are at least 18 years old. Persons under the age of 18 are not permitted to use or register for the Site.

Provided that you are eligible to use the Site, you are granted a limited license to access and use the Site and to download or print a copy of any portion of the Content to which you have properly gained access solely for

your personal, non-commercial use. We reserve all rights not expressly granted to you in and to the Site, the Content and the Marks.

USER REPRESENTATIONS

By using the Site, you represent and warrant that: (1) all registration information you submit will be true, accurate, current, and complete; (2) you will maintain the accuracy of such information and promptly update such registration information as necessary; (3) you have the legal capacity and you agree to comply with these Terms of Use; (4) you are not a minor in the jurisdiction in which you reside; (5) you will not access the Site through automated or non-human means, whether through a bot, script, or otherwise; (6) you will not use the Site for any illegal or unauthorized purpose; and (7) your use of the Site will not violate any applicable law or regulation.

If you provide any information that is untrue, inaccurate, not current, or incomplete, we have the right to suspend or terminate your account and refuse any and all current or future use of the Site (or any portion thereof).

SERVICES

KnoCard LLC offers a variety of free and paid cloud based software which may be accessed through the Website or Mobile App (the “Services”). Such Services include, but are not limited to, web and app based business/ personal promotional tools along with associated data storage. The Company reserves the right to add, modify or delete any of its Services at any time. In order to use the Services each member is required to create a personal account and complete a user profile. The Company may, at any time, add services to provide users with an enhanced product experience.

In such a case, KnoCard LLC reserves the right to create additional regulations, licenses, or terms of service in regards to such services.

USER REGISTRATION

Users will be required to register with the Site. You agree to keep your password confidential and will be responsible for all use of your account and password. We reserve the right to remove, reclaim, or change a username you select if we determine, in our sole discretion, that such username is inappropriate, obscene, or otherwise objectionable.

CONTACTS

KnoCard's in-app messaging feature requires the collection of the contact information from the user's mobile phone. Upon your acceptance of the terms, this information will be uploaded to your KnoCard app and stored on our server. You confirm you are authorized to provide us such numbers to allow us to provide our Services.

PREMIUM SERVICES AND SUBSCRIPTION SERVICE FEES

In addition to our free Services, the Company offers premium services that may be acquired through the Apple Store or Google Play as in-app purchases. Through the purchase of premium service(s), you consent to the Company's subscription-based service fees, which may be paid on either a monthly, or annual basis.

Although the KnoCard app implements the linking to and reporting of third-party services within some premium services, the Company charges premium service fees solely for content and reporting that is hosted on Company servers. Upgrades that include video/photo uploads/reporting merely pass on content and information from third-party sites and are not included in premium service pricing. For example, should you select an upgrade that includes 5 video uploads with reporting, you may upload a maximum of 5 videos from your mobile device, along with an unlimited number of videos from a third-party company.

REFUND/CANCELLATION POLICY

Due to the digital nature of the Company's Services, refunds will not be made on any Services. All Services are licensed on either a month to month or year to year basis and will be automatically billed unless you cancel Services. In the event of a cancellation, your subscription will remain in tact until the end of the monthly or annual service period. The Company will not offer prorated refunds.

POLICY REGARDING CHILDREN

Children under the age of 13 are prohibited from using our Services, and children between the ages of 13 to 18 may utilize our services only when supervised by a parent or legal guardian. Should the Company be notified that an unauthorized child has entered personal information using our Services, we will delete the information from our servers. If you wish to

PROHIBITED ACTIVITIES

Use License
